SCOUTREACH

This Cub-Scouting program is delivered with paid Program Specialist leaders to address the lack of volunteer capacity in low-income neighborhoods. We expanded enrollment by 11% this year, serving 9,204 boys in first through fifth grades from over 40 of New York City's most low-income neighborhood public schools.

EXPLORING

This worksite-based career exploration program served 6,755 young men and women ages 14-20 this year, a 15% increase over 2012. The following is an excerpt from a NY 1 story that appeared following the Exploring Academy graduation this past June.

"Very happy, proud," said Santa Ortiz, a mother of one graduate. The graduates were also brimming with pride, as their first steps in a life of law enforcement, or a career that's related, are now behind them.



"I've always wanted to make the streets safe, 'cause a couple years ago I got robbed one time, so that changed my mind," said Explorer graduate Bryan Encarnacion. "I wanted to become an officer, I want to change this."

The Explorers program combines physical and academic training in real-life policing scenarios. "The best part was going upstate for a

week at Camp Keowa," said Explorer graduate Fernando Pena. "I did things from rappelling, mountain climbing, obstacle courses. I learned about police scenarios. It was just overall a great experience. Everything was just fantastic equally."

Students can return to the program year-upon-year and add to their skills. Anelin Flete graduated to Explorer Lieutenant after four years. "We started at eight 'o clock in the morning and ended at three-thirty, so I got home probably around four-thirty, so that's like a regular school day for a lot of high school kids," said Flete. Many Explorers say that after just one year in the program, they get bitten by the policing bug and plan on continuing to participate in Explorers until they finish high school.




