

The pair had been swimming in a pool in Florida when they noticed another boy in the pool underwater who had not come back to the surface. Thanks to their intervention the boy made a full recovery.

"They took what we taught them, and fortunately we have a young person who is still alive because of their efforts," said the boys' Scoutmaster J.D. Stark. Jayden and Ty'zia were featured on **Brooklyn News 12**, and received the BSA national Meritorious Action Award.

## >> Times Square Pinewood Derby

### >> New Journalist Merit-Badge Pro-Series

**Events:** Scouts learned about careers in journalism from professionals at CNN and New York Times this fall, when these media titans opened their doors to Scouts in New York City. Scouts earned credit toward the Journalism Merit Badge for these two events. Highlights include personalized tours as well as presentation by New York Times Vice President and Life Scout Will Bardeen, and Pulitzer Prize winner Nick Kristoff.


>> New Lions Program: In 2016, 228 young boys were introduced to Scouting. It has been a "roaring" success. Kindergarten-aged boys are very eager to explore the outdoors, venture off, and make new friends. It's still a bright, new world full of curiosity for them, and we're here to teach them how to maneuver through it. Lions recruitment to the Cub Scouts has been a tremendous success. At this young, extremely impressionable age, our Lions are learning new skills, developing great early teamwork attributes and implementing them all while having the time of their lives!

>> Scoutreach and STEM: With technology at the forefront of our daily activities, the national office of the Boy Scouts of America has enhanced the teaching and learning of STEM-based skills through STEM NOVA, new merit badges and more. Locally, the Scoutreach division has developed a revamped 21-week interactive and expandable program designed to offer our middle school-aged Scouts opportunities to advance in Scout rank while learning and reinforcing the scientific method, critical thinking, problem-solving, and leadership skills.

Late last fall, Scoutreach expanded their school and community outreach with a five-week introduction to STEM LEGO Robotics. The incorporation of new technologies into our offerings will present Scouts with many opportunities to be empowered and pursue their interests. The new program was piloted in a limited number of schools in 2016, with broader outreach planned for the 2017 program year.

## >> 21st Annual Law Enforcement Leadership

Academy: Over 230 young men and women participated in the three-week academy, which brings students to classrooms at Fordham University for two weeks and to Camp Keowa for one week of drills, scenarios, zip lining, ropes courses, and other outdoor adventures in upstate New York. The Academy culminated in a graduation ceremony at One Police Plaza hosted by the NYPD.

The new John P. Ward Training Camping Area: This area serves as a testament to John's life of leadership and service and benefits Scouts and Scouters who participate in training at the Reeves Training Center at Alpine Scout Camp,

including National Youth Leadership Training, Wood Badge, Introduction to Outdoor Leader Skills, and other training

courses.

John P. Ward was a NESA Outstanding Eagle Scout and a dedicated volunteer. John served as Scoutmaster of Troop 728, Manhattan, Lodge Adviser of Man-A-Hattin Lodge #82, and

Wood Badge Trainer and Course Director. John was a Vigil Honor member of the Order of the Arrow, a Silver Beaver and Manhattan President's Award recipient, and a dedicated trainer of youth and adults over three decades.

William A. Clark Aquatic Center: In honor of over 40 years of professional service in Scouting, the William H. Clark Aquatics Center will serve as a permanent tribute to Bill Clark's service to Scouting. The completed renovations will improve the swimming pool and area, which is one of the most popular areas at John E. Reeves Cub World. Thank you to all who supported this work.



# JACK RUDIN In Memoriam

We remember Jack Rudin, former Boy
Scout and Ten Mile River camper, Silver
Beaver recipient, and long-time supporter
of the Greater New York Councils, Boy
Scouts of America. Jack was Chairman of
Rudin Management Company and one of New
York City's leading real estate builders and
owners. He was also a highly dedicated and
generous philanthropist. Jack was a patron of Ten
Mile River, especially Camp Keowa which was Camp
Manhattan when he and his brother Lew spent
summers there in the 1930's.


Jack loved New York, and along with his late brother, Lewis, carried on the tradition of their parents, Samuel and May, in business and public service, including establishing and funding for the Rudin scholarships for TMR Camp staff to fund their college studies.

Jack was born in the Bronx in 1924. He grew up in Scouting on Manhattan's Upper West Side. Jack was a husband, father, stepfather, grandfather, uncle, great-uncle, and great great-uncle.

Jack served in the U.S. Army during World War II and was a recipient of the Bronze Star for heroic and meritorious service in combat. Jack's stature as a business and civic leader was matched only by his devotion to improving the lives of the less fortunate, and he left an indelible mark on our city. As a builder, he oversaw the design and construction of some of New York City's most iconic building, his philanthropy and community involvement in health care, education, the arts and social services vastly improved the quality of life for many
